This agreement is entered into between Dive Oahu Inc. and _____ hereinafter "Renter", for the rental of scuba and/or skin diving equipment.

This Agreement is a release of the Renter's rights to sue for injuries or death resulting from the rental and/or use of this equipment. Renter expressly assumes all risks of skin and/or scuba diving related in any way to the rental and/or use of this equipment.

Renter hereby acknowledges receipt of the equipment designated in this form, and, if any of this equipment is to be used for scuba diving, that Renter is a certified scuba diver or student in a scuba diving course/program under the supervision of a certified scuba instructor.

Renter acknowledges that the equipment is in good working condition and that he/she has examined the equipment to ensure that it is free from defects including checking both the quality and quantity of air in any scuba tank(s) rented.

_____ Renter acknowledges that the equipment is due back on the day and time indicated on the rental agreement. Renter agrees to pay any additional fee of one day, rental at regular rental rate, for each day (or fraction thereof) the equipment is returned late.

_____ Renter acknowledges that loss of equipment or tank(s) or any damage to the equipment or tanks during the rental period is the responsibility of the Renter. Renter agrees to replace or repair equipment via Dive Oahu Inc. at current shop prices.

_____ Renter agrees to rinse gear in fresh water before returning and to ensure gear is free of sand/dirt before returning to Dive Oahu Inc. If gear is not returned in a satisfactory condition a \$15 service fee will be charged.

_____ Renter agrees that tanks will be returned with a minimum of 200 PSI anything less than that will result in a \$15 service fee.

_____ Renter acknowledges that credit card information being provided will only be used per this agreement and Renter authorizes Dive Oahu Inc. to make charges.
